SUMMER 2018 EARLY START UC HEALTH INSURANCE PLAN (UCSHIP)
HEALTH INSURANCE AGREEMENT – INTERCOLLEGIATE ATHLETES (UNDERGRAD)

MANDATORY INSURANCE REQUIREMENT:

As a non-academic condition of enrollment at UCSD, the UC Regents require all registered students to have adequate health insurance coverage and therefore provides the UC Student Health Insurance Plan (UC SHIP), which is a comprehensive health insurance plan. All registered students, including intercollegiate athletes, are automatically enrolled in UCSHIP. Students already enrolled in a comparable health insurance plan may waive UC SHIP coverage by completing a Health Fee Waiver application during the FALL 2018 waiver period. Comparable coverage must meet the requirements set by the UC Regents.

EARLY START UCSHIP:

Since your athletic program begins prior to the start of the official campus fall quarter (September 24, 2018), Early Start UCSHIP coverage is being offered to you for Summer 2018. **Students enrolling in the Early Start UCSHIP for Summer 2018 are NOT eligible to waive the UCSHIP during the FALL 2018 waiver period.**

COST OF UCSHIP:

The cost of Early Start UCSHIP is a one-time supplement fee, prorated based on your program start date. This fee (see below) is separate from the quarterly UCSHIP fee of \$657.00. If you elect to enroll in the Early Start coverage, the Early Start fee will be charged to your campus billing account. The supplemental Early Start fee will be as follows:

The supplemental Early Start fee for Summer 2018, will appear on the student's August 2018 e-bill statement and must be paid by the corresponding billing due date. The quarterly UC SHIP fee will automatically be charged to the student's campus billing account along with the other mandatory registration fees and must be paid prior to the FALL 2018 billing due date.

HEALTH INSURANCE AGREEMENT INSTRUCTIONS:

- **All ICA fall quarter student-athletes whose first team meeting is before September 24, 2018 must complete this form.**
- **Return page 2 of this completed form to the ICA Certified Athletic Trainer on or before the date of your first team meeting. Please keep page 1 for your records.**
- Students electing to waive Early Start UCSHIP must complete this form AND submit an on-line Health Fee Waiver application on or before the date of their first team meeting.
- Students who submit a Health Fee Waiver and are selected for audit will be required to submit the requested audit information immediately. **If the student does not respond to the audit request or if the waiver is not approved, the UCSHIP fee and supplemental Early Start fee will be charged.**
- **Student-athletes who do not make the team or later choose not to participate will still be charged the UCSHIP fee and the supplemental Early Start UCSHIP fee.**

- After my coverage start date, I will not be eligible to waive the UC SHIP for Early Start or FALL 2018 under ANY circumstances (including failure to make the team, deciding not to participate in ICA, existence of other coverage, etc.). If I submit a waiver during the fall quarter waiver period, my waiver for fall quarter will be denied/reversed, and I will be charged the fees mentioned above.
 - I will be billed for the FALL 2018 UCSHIP fee of \$657, and the supplemental Early Start UCSHIP fee indicated above.
 - I will be eligible to request a waiver beginning with the Winter 2019 quarter, if desired.
- No, I do not want to enroll in the Early Start UCSHIP for Summer 2018.** I understand that:
- I am confirming that I have other insurance coverage which will cover me through September 23, 2018.
 - I am not eligible to enroll in UCSHIP until Fall 2018 unless my other insurance coverage ends before then.
 - **I am still required to submit an on-line Health Fee Waiver** application during the FALL 2018 waiver period to waive the regular academic year. If I do not submit a waiver, I will be enrolled in the UCSHIP effective September 24, 2018.
 - If my waiver is selected for audit, I will submit the requested documents immediately. If I do not submit the required documents, my waiver will be denied and the above fees will be charged.
- I am currently enrolled in the UCSHIP for Spring 2018 therefore Early Start does not apply to me.**
